2025-2026 Payment Plan Dues Summary Dues Category Information

- Social Spouse:** Available to spouses that will not be sliding but would like to be involved in the Club. **Able to purchase and use maximum of two (2) lift tickets per season**, ineligible for exchange privileges. CCL included in dues.
- New Parent:** Available for those with children under 2 years of age. Full use of Club with no limitation on sliding. CCL included in dues.
- Full Time Student:** Available to junior members enrolled in full time post-secondary studies. Unlimited sliding. CCL included in dues. **Please note we will require proof of enrollment prior to issuing badges.**
- Inactive:** Available to voting members in good standing. Application required each season. All family members become inactive. CCL in addition to dues. Enables member to have Social use of the Club with guest sign in privileges (guest policy applies), **junior options remain alive**. Able to purchase and use a maximum of two (2) lift tickets per person per season, no reciprocal privileges, nor able to purchase or use guest ticket voucher purchase privileges. **Inactive status applications need to be received by the Club annually by September 30th to be reviewed by the board.**
- Non-Voting 60+ Inactive:** Available to voting members in good standing who are 60 years and up. Application required each season. All family members become inactive. CCL included in dues. Social use of the Club with guest sign in privileges (guest policy applies), **junior options remain alive**. Able to purchase and use a maximum of two (2) lift tickets per person per season, no reciprocal privileges, not able to purchase or use guest ticket vouchers. Member will forfeit the right to vote at Club AGM. **Inactive status applications need to be received by the Club annually by September 30th to be reviewed by the board.**
- Part Time:** Available for members who have been voting members with at least 15 years tenure. Only one family member may shelter under voting member. Permitted to ski 2 weekend days in January & February, unlimited weekday skiing as well as December & March. Ski Tickets obtained at ticket window. Access to all social & lifestyle activities. Junior Options stay active, full voting rights & return to full time status guaranteed. Able to purchase vouchers. No access to programs, no exchange privileges.
